Whether you come to us with an illness, multiple medical problems or for a health evaluation, our **Goal** is to help you move as quickly as possible to wellness and have your emphasis be on the prevention of disease. We believe that some essential ingredients for promoting optimal health are: a good nutrition program, proper stress management, a balanced exercise program and improved health awareness.

Getting healthy and staying healthy involves acquiring and maintaining a constant balance in all areas of our lives. At PMCM, we practice **Integrated Medicine**, a multi-disciplinary approach focusing on general family medicine, emphasizing the prevention of disease and the use of natural therapies, all within a framework of Western medicine.

As a new patient, your first visit may include a complete health history, a physical examination, and various tests such as biochemical and nutritional analyses along with other selected diagnostic procedures.

Our practice specializes in yearly health evaluations and personalized programs which may include: analysis of nutritional needs, pharmaceutical and naturopathic remedies, osteopathic evaluation and treatment along with acupuncture and other body therapies.

Billing: For patients with insurance where we are a participating provider, co-payments and un-met deductibles are due at the time of service. If deductible amount is uncertain, we will submit your claim to the appropriate carrier. Any amounts remaining will be due and payable upon receipt of insurance company's Explanation of Benefits.

For patients who pay cash, and/or have an insurance plan where we are a non-participant, fees are due and payable at the time of service. This includes the office visit, any and all diagnostic and lab test fees, as well as recommended nutritional supplements.

PCMC will provide all necessary paperwork for patients with private insurance for submission to their carriers.


For your benefit and ours, it is imperative that you keep your scheduled appointment or give us ample notice if you must change your appointment. To assist you, our staff will confirm your appointment 24 to 48 hours prior to your scheduled visit. For appointments canceled 24 hours or less before your scheduled visit, it is necessary for us to charge you. There is a \$100.00 charge for missed or late-canceled first appointments, and a \$75.00 charge for subsequent missed or late-canceled appointments. We hope that informing you of this policy will prevent us from ever having to enforce it.
