COMPLAINT FORM

The Board investigates complaints against Registered Geologists, Registered Geophysicists, Certified Engineering Geologists, Certified Hydrogeologists and individuals practicing geology or geophysics without a license. Investigations can involve many aspects of geology including but not limited to evaluation of landslides and slope stability, fault investigations, real estate disclosures, groundwater contamination and groundwater resource evaluations.

The Board's authority allows action against an individual's license within the provisions of the Geologist and Geophysicist Act (Act). Cases requiring discipline against an individual's license can result in administrative actions including issuing citations and fines up to \$2,500 per incident and license probation, suspension or revocation. The Act and Rules and Regulations are available from the Board on its website, above, or upon request from the Board at the address, telephone number or e-mail above.
